PULITZER PRIZE AWARDED TO PRESS DEMOCRAT FOR WILDFIRE COVERAGE

The Press Democrat was awarded the Pulitzer Prize on Monday [April 16, 2018], the highest award in American journalism, for its coverage of the most devastating wildfires in California history.

The newspaper was honored in the category of Breaking News for its online and print coverage of the October fires, which killed 40 people and destroyed 6,190 homes in the region.

The Pulitzer Committee lauded the paper "for lucid and tenacious coverage of historic wildfires that rayaged the city

of Santa Rosa and Sonoma County, expertly utilizing an array of tools, including photography, video and social media platforms, to bring clarity to its readers — in real time and in subsequent in-depth reporting."

The newsroom on Mendocino Avenue erupted in cheers and hugs as the awards were announced shortly after noon. While the paper has won several other journalism awards for its fire coverage, snaring a Pulitzer is the pinnacle of American journalism.

"This is such a proud day for our newsroom. Our staff headed directly toward the flames to bring powerful and continual reporting of this story, even as they sent their families to safety," Executive Editor Catherine Barnett said.

"So many of our friends and families lost their homes and so much more on that October night. While we celebrate today with journalism's highest prize, we keep them in our hearts."

Press Democrat publisher Steve Falk, who took the helm of the paper after its 2012 acquisition by Sonoma Media Investments, said he couldn't be prouder of the newsroom. "The real test of a newspaper is in a disaster, and our journalists rose to the occasion when our community needed them most," Falk said.

PUBLIC INPUT NEEDED ON WATER SUPPLY, FLOOD PROTECTION, AND SANITATION DISASTER PLANNING

The Sonoma County Water Agency has released a draft of its updated Local Hazard Mitigation Plan (LHMP) that creates a blueprint for reducing the damage to the Water Agency's infrastructure from natural disasters, such as floods, droughts, fires, and earthquakes. Members of the public are invited to submit comments on the draft LHMP during the 30-day public comment period that opens on April 18, 2018. To review the LHMP and provide input, visit: www.sonomacountywater.org/secureourwater/.

An LHMP forms the foundation for a community's long-term strategy to reduce disaster losses and break the cycle of disaster damage, reconstruction, and repeated damage. The planning process includes public and stakeholder involvement. The Sonoma County Water Agency is working with its stakeholders to complete an update of the 2013 LHMP.

The Water Agency must update its LHMP every five years to ensure it remains relevant to current events and system conditions and to meet requirements set forth by FEMA. In particular, staff has reviewed the Water Agency's vulnerabilities and risks, as well as the prioritized listing of hazard mitigation actions.

LHMPs are public documents that create a framework for risk-based decision making to reduce damage to lives, property, and the economy from future disasters, such as earthquakes, fires, and floods. The Federal Emergency Management Agency (FEMA) utilizes LHMPs to issue grant funding for pre-disaster and hazard mitigation actions.

In 2004 the Sonoma County Water Agency initiated a natural hazard assessment, which was instrumental in creating the Water Agency's first LHMP in 2008. This LHMP was updated in 2013, and includes a priority listing of hazard mitigation actions.

SONOMA COUNTY WINE AUCTION RAISES OVER \$840,000

The fourth annual Sonoma County Barrel Auction raised \$840,700, a 6 percent increase over the previous year.

About 500 people attended the event held Friday at MacMurray Estate Vineyards in Healdsburg. Included in the total amount raised was \$99,000 to assist those who were affected by the October wildfires, the announcement by Sonoma County Vintners stated.

That included two special 20-case "Sonoma Rising" barrel lots benefiting the Sonoma County Vintners Emergency Relief Fund. Sonoma Rising "Resilience" — a pinot noir produced with fruit from Russian River Valley and Sonoma Coast and crafted by the winemakers from AldenAlli, Arista Winery, Benovia Winery and Williams Selyem — fetched \$70,000. Sonoma Rising "Fortitude" — a 2016 cabernet sauvignon from Aperture, Lambert Bridge Winery, Laurel Glen Vineyard and Mauritson Wines — was sold for \$29,000.

The 2018 Sonoma County Barrel Auction sponsors included MacMurray Estate Vineyards, American AgCredit, Silicon Valley Bank, G3 Diam Enterprises, Tonnellerie Cadus, Kosta Browne, MacRostie Winery & Vineyards, Martin Ray Vineyards & Winery and Francis Ford Coppola Winery.

Supporting sponsors included BPM, Carle Mackie Power & Ross, ETS Laboratories, Out the Bottle, Pack n' Ship Direct, Paragon Label, Tonnellerie Tremeaux, and Sonoma Millworks Design.
