PROGRESS ON WIKIUP COMMONS

There are lots of meetings and talk going on in our community regarding Wikiup Commons.

Kristin Maharg Suarez presented the Community Soil Foundation and some of its current programs to the Mark West Citizens Advisory Council, explaining some of their involvement with the fire recovery process and Wikiup Commons.

This is their fourth year growing in Larkfield and they supplied many trees to the people whose lots and homes burned. They also served the families, helping with contamination and erosion control and started a program called Healthy Habitats.

The most recent project is at Wikiup Commons, working with the Banke/Jackson family and some interested community members to give a conceptual design for the 16-acre park site, balancing the health of the land and need of the community.

There is a once in a lifetime opportunity for the community to have access to this land, being donated by the Banke/Jackson family, as a park for all of Mark West to use. Many organizations and community members are working together, exploring possibilities of a few different entities, one of which could, hopefully, take possession of this 16-acre parcel.

They are also all working together to acquire large scale funding for the restoration of Mark West Creek. Clean up and restoration would be a major part of this project and many organizations would be involved in it.

Along with the restoration project, they are exploring funding sources to build a pedestrian bridge, creating an egress and safer walking to schools, etc. for the children in Wikiup and possible additional emergency services access.

Community Soils is working with the community, Sonoma County Parks, creek restoration organizations and inviting the Mark West Citizens Advisory Council to participate, hoping to put the community stamp on the project.

PROPOSED MARRIOTT HOTEL IN BURN ZONE DENIED APPROVAL BY SANTA ROSA PLANNING COMMISSION

Santa Rosa planning commissioners have blocked a large hotel project in Fountaingrove, citing the potential peril posed by future wildfire among their chief concerns, and foreshadowing a looming fight over the extent of new commercial development allowed in one of Sonoma County's biggest burn zones.

The first-of-its-kind decision came in a 3-3 vote Thursday by the city's Planning Commission, which withheld approval of a use permit for the 114-room, three-story Residence Inn Hotel by Marriott. It is envisioned for a 4.6-acre site just north of the former Hilton Sonoma Wine Country hotel and the Fountaingrove Inn, both of which were destroyed in the Tubbs fire in October 2017.

The outcome reflects the city's ongoing struggle to balance public safety with its stated commitment to facilitate redevelopment of burn zones. Officials vowed even in the immediate aftermath of the fire not to stand in the way of homeowners looking to rebuild in Fountaingrove, which lost nearly 1,600 homes in the Tubbs fire.

"I'm not against Marriott and think it would be appropriate to build an office building on that site, but (I) am against potentially putting tourists and business travelers, who may be unfamiliar with the area, in harm's way in the event of a firestorm," said Vicki Duggan, a planning commissioner who voted against the use permit.

Property owner Billa Management and development partner Tharaldson Hospitality have until Dec. 10 to appeal the deadlocked decision to the Santa Rosa City Council.

SONOMA COUNTY STARTS OVER WITH SALE OF CHANATE ROAD PROPERTY ONCE EYED FOR 867 DWELLINGS

Sonoma County supervisors Tuesday took the first step in once again putting a sprawling piece of property in northeast Santa Rosa up for sale, hoping to draw a wider variety of developers by cutting it up into smaller parcels.

The land off Chanate Road will be offered first to designated public agencies or housing sponsors for the development of affordable housing, parks or school facilities, officials said. Those entities will have the option to submit offers to buy the property as a whole 71.62 acres or as three separate parcels.

An appraisal is expected to be completed by January, with a call for proposals from affordable housing developers, schools and cities by February, General Services Director Caroline Judy said.

Those offers will come back to the board by May for consideration in a public meeting, when supervisors will evaluate the offer price against the fair market and appraised values. Certain parcels would be excluded from a potential sale, including a 26-acre plot owned by the Sonoma County Water Agency and a nearly 10-acre parcel with an oak-studded meadow off Beverly Way that will be dedicated for public access and use.

"The mixes and uses of the property will be determined by the city of Santa Rosa," Judy said. "The Board of Supervisors will only consider the price proposals as submitted."

State law requires the county to first offer the property for sale to certain government agencies and qualified nonprofits. If that process is unsuccessful, supervisors could once again seek offers from the private sector. The sale could take a year, Judy said.
