### **UPDATE FROM THE MARK WEST COMMUNITY SERVICES COMMITTEE:**

On January 8th the Sonoma County Board of Supervisors approved the funding of an additional study to determine the feasibility of creating a Community Services District in the Larkfield/Wikiup area.

On January 14th the MWCSC met with Supervisor Paul Kelley and other members of the County to discuss district formation. It has been determined that formation of a smaller district with a focus on the urban areas of Larkfield would be a good first step. The MWCSC will move forward based on the study findings which will hopefully be available in March of this year.




