

As a major supporter and participant, Levi has been extremely instrumental in keeping a stage of the Tour of California here in Sonoma County closely working with local officials, speaking at public events and organizing fundraisers and groups. This past October Levi hosted his inaugural King Ridge Gran Fondo bike ride. All the funds raised from entry fees went to help benefit keeping Santa Rosa as a stage location on the Tour of California, and also to benefit Forget Me Not Farm of Sonoma County...two groups that are near and dear to Levi's heart.

Levi and his wife Odessa Gunn (a former World Class professional cyclist herself) actively support various animal welfare causes. With 18 pets of their own and welcoming over 100 foster animals into their home over the past 10 years as part of their animal rescue work, Levi and Odessa are spokespeople for PETA with Levi appearing in public service announcements promoting the importance of animal population control and welfare. Odessa is a board member for the Sonoma County Humane Society's Forget Me Not Farm as well as A Leg Up, which is a small dog rescue project here in Sonoma County. They are supporters of various animal-rescue groups and shelters and are devoted advocates of similar animal rights initiatives such as Forgotten Felines of Sonoma County. As Odessa once said, "It's my life ambition ... my purpose in life. Every night I go to bed thinking of all the suffering of animals. It's so daunting." On September 1st, Odessa influenced her friend Sheryl Crow to come to Santa Rosa for a performance at the Wells Fargo Center to benefit Forget Me Not Farm, Forgotten Felines and A Leg Up. Odessa and Levi have made their home in the Mark West Area of Santa Rosa for the last 10 years.

MESSAGE FROM MWUSD SUPERINTENDENT

I hope you are looking forward to a fun and festive holiday season. The fall semester was successful and we are committed to continuing to provide the highest quality of education and service for the youth of our community. We are looking forward to a successful 2010.

As you may know, the District is in the process of assessing our school facilities and planning for potential improvements. We have accomplished so much in the last decade to improve our schools, including the new multipurpose room, library and computer lab at Mark West Elementary, new administrative office and other improvements to San Miguel Elementary, and the new classrooms at Riebli Elementary, pending State funding.

The community's support of Measure "I" in 2002 helped the District qualify for \$3 million in State funding to improve our schools.

Local support and Measure "I" helped meet our school facility needs over the last decade, and now we are assessing our capital needs for the next ten years. This planning will help us maintain our investment in our schools and continue to provide an excellent education for all our students. Our school facility needs include:

- Completion of the new classrooms at Riebli School
- Renovate or replace portables at Mark West, Riebli, & San Miguel schools
- Modernize classrooms and facilities, including providing new roofing, heating, and air conditioning at all schools
- Improve student access to computers and modern technology
- Improve safety and traffic flow at Riebli school
- Provide permanent facilities for Mark West Charter School

The District is currently reviewing options to finance these improvements. One of the options under consideration is a general obligation bond measure. The earliest a bond measure could be on the ballot is June 2010. Any proposed bond measure would require an independent oversight committee and annual audits to ensure money is used only for voter approved school improvements and repairs and not used for salaries, administration, and overhead.

We will be holding a series of school site meetings in January for parents to meet with the District and school site staff to discuss these school facility needs. We encourage all parents, community members, and school staff attendance and active participation in these meetings scheduled as follows:

- Mark West Elementary January 14, 2010 at 3:30 P.M. in the Music Room
- John Riebli Elementary January 20, 2010 at 6:30 P.M. in the Multi-Use Room
- San Miguel Elementary January 22, 2010 at 9:00 A.M. in Room 25


