


BRINGING BUSINESS & THE COMMUNITY TOGETHER!

SUPERVISOR KELLEY ENCOURAGES THE FORMATION OF THE MARK WEST AREA COMMUNITY SERVICES DISTRICT

Supervisor Kelley has identified a variety of benefits to forming a community services district for the Mark West Area. A study on district formation is nearing completion and will likely lead to a more formal proposal to the Board of Supervisors and LAFCO.

Some of the reasons for district formation have been identified as follows:

- The Mark West Area has the largest population of any unincorporated area within Sonoma County.
- As the Fourth District Supervisor, Paul Kelley represents a very large geographical area, stretching from Santa Rosa to north of Cloverdale. His responsibilities include all of the land use decisions in the unincorporated areas, roads in the unincorporated areas, airport and railroad services, and lots of others including the controversies surrounding casinos. This requires a great deal of attention at the county level, which leaves less time available for focusing on other matters.
- The formation of a community services district (CSD) in the Mark West area would allow certain services to be administered by a locally-elected board that would be more directly accountable to the local residents.
- A CSD would not have jurisdiction over land use, but the CSD Board could provide a collective voice to the County Planning Commission and Board of Supervisors.
- The CSD Board could also comment on any matter of local concern as representatives of the community.
- The CSD could assume operation of existing street lighting and landscape maintenance functions from the County as will be addressed in the District formation study. Once the CSD is formed the Board could negotiate with Homeowner's Associations to assume maintenance of their common areas and conceivably achieve some savings for the HOAs by consolidating those functions over the entire District and bidding out the work on an annual basis. The CSD could negotiate a split of any savings to secure income to the CSD for administrative functions.
- The CSD could raise the funds to contract with the County Sheriff for an increased law enforcement presence.

- The CSD could raise funds to operate a community center. A Community Center could be operated on a fees for service basis to assure it provided adequate income to cover its expenses and to retire the construction debt.
- The CSd may be able to take over various other services, and based on the results of the study, be able to realize a limited amount of revenue to operate the district. For example, the California Special Districts Association is supporting SB1191 to allow CSDs to provide broadband service.
- A number of services could remain latent and be activated at a later date, when needed.

FYI: ASSEMBLY OKS PAID SICK LEAVE FOR ALL

California would become the first state to require paid sick leave for every worker under legislation passed Wednesday by the Assembly.

The California Chamber of Commerce, in a letter of opposition, noted that many employers voluntarily offer paid sick leave. But AB 2716 could hurt businesses that lack the money or expertise to expand their record-keeping and payroll reporting, the chamber said. "In an already troubled economy, California should be seeking ways to stimulate job growth and avoid forcing costly mandates on employers," the group wrote.







