### **UPDATE ON DISTRICT FORMATION**

After many years of preparation, the formation of a community services district for the Mark West area took a significant step forward on February 2, 2010. On that day, the Sonoma County Board of Supervisors voted unanimously to sponsor an application to the Sonoma Local Agency Formation Commission (Sonoma LAFCO) for creation of the District. This decision came after members of the community submitted over 500 signatures of interest from the community and the local supervisor, Paul Kelley, explained the benefits of forming a district. The Mark West Area Chamber of Commerce played a significant role in helping to gather the signatures.

If approved, a few services currently provided by the County (such as lighting) would be transferred to the District. The District could also function as focal point for securing grants that could be used for improving various functions in the community.

Did you know that many people spend more time planning their vacation than planning for retirement? Although there are many ways to save for your retirement, if you are like most people, you aren't taking full advantage of them. For example, do you understand the basics of a Roth IRA? If not, here's a little Roth IRA 101.

Right now, you may be wondering why you should invest in a Roth IRA if you currently have a retirement plan with your employer. The Roth IRA has many benefits that other retirement plans don't have, and chief among them is the fact that any investment earnings may accumulate tax-free. In other words, your Roth IRA has the opportunity to grow without incurring any taxes and can be distributed to you tax free, if certain conditions are met.

While there are advantages to owning a Roth IRA, there are also some rules to think about before you decide this is the account for you. First, not everyone can take advantage of a Roth IRA. You or your spouse must have earned income or compensation – this includes wages, tips or salary. However, be aware that earned income or compensation does not include rental, interest, dividend, pension annuity or deferred compensation income. Second, your modified adjusted gross income cannot exceed certain limits to make a full contribution. For single people, your modified adjusted gross income must be less than \$105,000 and \$166,000 for married couples filing jointly.

Contributions you make to the account are not tax deductible but may be withdrawn any time without tax or penalty. Before taking withdrawals from your Roth IRA you need to determine if you are receiving a "qualified distribution." Any withdrawal that is not a "qualified distribution" can result in income taxes and IRS penalties. For example, any earnings on your principal will be subject to income taxes should you decide to withdraw them prior to the five-year holding

Since environmental and economic issues are often overwhelming, finding practical strategies and profitable solutions that benefit our local communities and spiral outward is a focal point for many of us. Currently I am studying to be accredited as a LEED Green Associate in order to assist others in finding their way through an often mindboggling maze of sustainability.

Greening our homes and businesses results in not only rejuvenating the environment, but also growing our bottom line – which inevitably makes us happier and healthier. *May I make two suggestions?*

While the action of the Board of Supervisors was very significant, the upcoming steps will require a tremendous amount of effort and commitment. In order to be successful at the commission level, the application will need to clearly define the merits of the proposal and its financial viability. If the proposal is approved by LAFCO by late spring, the Board of Supervisors would be in position to call for an election within the boundary of the proposed district that would appear on the November ballot. A successful election will require the efforts of many individuals in explaining the merits of the proposal to the voters.
