PRESIDENT'S MESSAGE

BUSINESS SPOTLIGHT EXTENDED CHILD CARE: CARING FOR THE FUTURE

One of the most important parts of participating in a community is planning for the future. If someone were to ask what the most important part of the future is, they would receive a number of different responses. However, one of the most common answers to the question is "children."

If children are given the tools they need to succeed, then both their future and the future of the community are much improved. It is from this belief that Extended Child Care operates, so that children throughout Sonoma County can experience life to the fullest.

Extended Child Care was founded in 1978 for the purpose of providing oncampus care for school-age children, both before and after school. Originally a subsidized organization for families in need, Extended Child Care soon had a shift in thinking that opened the doors to allow for private payment by families, while maintaining subsidized care for those in need. Now, covering the Mark West Union, Windsor Unified, and Wright school districts, Extended



Extended Child Care is committed to assisting each school-age child in obtaining life skills by providing quality year-round learning programs, while supporting families and school districts. Their programs include after-school education, homework time, guided recreational activities, physical activities, and just plain fun!

Child Care has become a mainstay in the community, with current Executive Director Jason Riggs noting that the presence of Extended Child Care can convince parents to enroll their children at one school instead of another, providing both peace of mind for the family, and economic support for a local business.

Since its founding, Extended Child Care has operated very smoothly. Three Executive Directors have operated the business over the years, and current Executive Director Jason Riggs is excited to continue supporting the community and the chamber of commerce that have welcomed Extended Child Care with open arms. Having hosted socials in the past, Jason is excited to help the Mark West Chamber of Commerce at its various events this year, including hosting during the official re-opening of Extended Child Care on the John B. Riebli Elementary School campus.

As with a majority of businesses in the Mark West Springs area and beyond, Extended Child Care suffered loss as a result of the Tubbs fire in 2017. Due to the fires, 51 enrolled children and four members of the Extended Child Care staff lost their homes to the fires, as well as the loss of the company's buildings on the Riebli campus. However, this tragedy soon gave way to another display of community as groups such as United Way and Redwood Credit Union helped provide Extended Child Care with rebuild assistance and support to the displaced members of the staff and community.

All in all, Extended Child Care has worked tirelessly to provide the community with the care its future generations need. Though the long-term impacts of the Tubbs fire are still unknown, the business stays strong and stands with its community, with Jason saying, "The best part of what we do is seeing a child who doesn't want to go home after school, and knowing that they're happy and engaged so that their parents don't worry. We deeply appreciate the support from the Chamber over the years, and look forward to continuing that partnership."

NORTH BAY UNEMPLOYMENT MOSTLY CONTINUES AT LOW POINT IN FEBRUARY

California's unemployment rate last month was virtually unchanged from a year ago, according to state figures released Friday.

The joblessness rate was 4.2 percent in February, compared with 4.3 percent the previous February, according to estimates from the California Employment Development Department.

In the North Bay, three counties reported lower unemployment rates than the state's rate: Marin County, 2.5 percent; Napa County, 3.4 percent; and Sonoma County, 3.1 percent. Solano County was barely higher, at 4.4 percent, while rates in Lake and Mendocino counties were significantly higher than the state, at 6.1 percent and 5 percent, respectively.

The U.S. unemployment rate decreased by 0.2 percentage points to 3.8 percent, and the nation's employers added 20,000 nonfarm payroll jobs.

Sonoma County

The unemployment rate in Sonoma County in February decreased from a revised 3.3 percent in January but was above the year-ago estimate of 3.0 percent.

The county added jobs in the mining, logging and construction industry, as well as in financial activities, leisure and hospitality, and government. Fewer jobs were available in trade, transportation and utilities; professional and business services; and educational and health services.

Napa County

The unemployment rate in Napa County in February decreased from a revised 4.0 percent in January and was unchanged from the year-ago estimate of 3.4 percent.

Jobs in the county were added chiefly in leisure and hospitality, government, professional and business services, and trade, transportation and utilities. While other industries remained flat, there was no decline in available jobs.



COFFEY PARK HOME REBUILDING RAMPS UP IN SANTA ROSA

Hillary Court was once a serene and picturesque cul-de-sac, and will be again someday.

But not anytime soon. These days, like most of Santa Rosa's Coffey Park neighborhood, it is a bustling, boisterous, borderline anarchy of contractors and suppliers, inspectors and utility workers, all doing their best to not inconvenience the handful of residents who've already moved back in.

"It's tough for us in the winter, 'cause we can't really work if it's raining too hard," said carpenter Dylan Johnson, eating a Clif bar in the bed of a pickup during his Thursday midmorning break. "But now that it's drying out, it's going to be nonstop."

Atmospheric rivers had been replaced, on this day, by sunshine and a steady stream of pickups, cement mixers and heavy equipment up and down Hopper Avenue. With the advent of a new building season, reconstruction in Coffey Park has ramped up to a level unseen since the start of the rebuilding, following the October 2017 Tubbs fire that destroyed 1,422 homes in this working-class community.

A full 70 percent of the burned Coffey Park properties are "either under construction or have reached completion," said Gabe Osburn, Santa Rosa's deputy director of development services. And more owners have been issued permits, but not yet begun construction.

"We are definitely running at full throttle out there," said John Allen of APM Homes.

That wasn't the case last year. By October 2018, a year after the fire, only 21 houses had been rebuilt and 520 were under construction. Today, 17 months after the disaster, 191 homes in Coffey Park have been completed, while another 689 are under construction.

Jeff Okrepkie, president and founder of neighborhood support group Coffey Strong, expects some 700 rebuilt homes to be occupied by midsummer.


