SONOMA COUNTY TOURISTS SPEND ALMOST \$2 BILLION IN 2016



Travel spending in Sonoma County was \$1.93 billion for 2016, growing by 5,7 percent over 2015, according to figures released Thursday from Visit California, the state's tourism agency.

Travel spending in the county in 2015 was \$1.82 billion.

"Tourism is an important economic driver for Sonoma County," stated Ken Fischang, president and CEO of Sonoma County Tourism, the marketing organization for the county, in the announcement. "We are very pleased that we continue to show a return on our investment in tourism marketing, which translates to local jobs and government revenue."

There has also been a 5.3 percent increase in government revenue from tourism in the form of local and state taxes, bringing in \$158.4 million. That monev is used locally for regional parks, public safety, economic development, agricultural promotion, and arts and cultural festivals as well as general funds for cities and the county, according to the tourism impact report.



The report also states each household in Sonoma County would pay an additional \$820 a year in taxes to make up for the tax revenue attributed to tourism.

The total number of jobs in the tourism economy also grew by 3.1 percent, with 20,410 jobs now in the tourism sector locally. That equates to more than one in 10 private employer jobs in Sonoma County.

Hospitality jobs are varied in Sonoma County, with tour guides, restaurateurs and brewery tasting room staff just as likely to interact with a visitor as a hotel front desk clerk. And this doesn't include the supporting businesses needed for the industry like commercial laundries, farmers, and all types of business services.

According the Sonoma County Economic Development Board's annual tourism report, 91 percent of Sonoma County tourism businesses are locally owned and 82 percent are small businesses, employing fewer than 24 employees.

NORTH BAY UNEMPLOYMENT DROPS IN APRIL, AND JOB GROWTH SLOWS

Unemployment rates across the North Bay continued to fall during April, some to new historic lows, according to state figures released Friday.

All six counties lost several 10ths of a percentage point, including Marin, which dropped below 3 percent, according to preliminary estimates from the Employment Development Department. Sonoma County's rate was the lowest in 16 years, and Marin's the lowest since December 2000. Rates for all the region's counties remained well below where they were a year before.

As the unemployed proportion of the workforce dips to such low levels, job growth is decelerating to a crawl. Total employment in Sonoma County increased by only 500 over the past 12 months, or 0.2 percent (0.6 percent for nonfarm jobs). That's the slowest annual job growth for April in five years. In Marin, total annual job growth was 800 positions, or 1.1 percent, which is a two-year low.

Industry gains across the board included jobs in government, with Sonoma gaining 900, Marin gaining 500, Solano up 400, and Napa gaining 300.

Hospitality Slows; Health Care Grows

After months of year-over-year growth, leisure and hospitality industry hiring mostly leveled out in the state figures. That's except for Solano, which had 600 new jobs, and Mendocino, with 100 more.

Solano is also seeing continued growth in education and health services industry, with 1,100 new jobs, followed closely by Sonoma with 1,000, and 300 in Marin, and Napa.

Industry losses for the year varied by county. Aside from manufacturing, Sonoma lost 500 jobs in retail-dominated trade, transportation and utilities. Solano lost 500 in professional and business services, and Marin lost 300 in leisure and hospitality, after having a 600-position net annual gain in March.

Sonoma County

The unemployment rate in the Sonoma County was 3.2 percent last month, down from a revised 3.6 percent in March and below the year-before estimate of 3.9 percent.

This compares with an unadjusted unemployment rate of 4.5 percent for California and 4.1 percent for the nation during the same period.

The county maintains the fifth-lowest jobless rate in the state, preceded by these counties: Santa Clara, San Francisco and Marin tied for second, and San Mateo.

The number of Sonoma nonfarm jobs was 202,500, up 1,200 for the year. Farming employment was 5,600, down 700 for the year.

Leading job-adding industries over the year were professional and business services, up 1,300, or 6.3 percent, to 22,000; educational and health services, up 1,000, or 3 percent, to 34,100; construction, up 500, or 4.1 percent, at 12,700; and government, up 900, or 2.8 percent, to 33,600.

Job-losing sectors over the year were manufacturing, which includes winemaking, down 2,000, to 20,300; trade, transportation and utilities down 500, to 36,000; and financial activities, down 300, to 8,200.
