#### **BLOODY BUT UNBOWED**

Well, I'm willing to admit it. I don't believe in the Loch Ness Monster anymore. I'm beginning to doubt that Bigfoot exists. Aliens are too far away, if they exist at all. But I'm not willing to give up Santa Claus. Because "giving" is the greatest gift and Christmas and good old Santa are all about giving.

So, what do we have to give now to help our community feel safe?

We have had three unbelievable devastating wildfires in Northern California the last three autumns. Two affected our neighborhoods. I don't want to believe in that. I want to pretend it never happened, but I can't. I am reminded of that fact every day.

I investigated and photographed the destruction by fire of two pieces of rental equipment owned

by the company I work for. I was allowed into areas of our county that suffered extensive fire damage. I could not find the other three pieces I needed to photograph, as they were buried beneath a burnt and collapsed metal building. Yes, these wildfires melt metal. I saw landscapes and views of where I live that I don't want to remember. While searching for our rental equipment I was following the path of a fire that came within a mile of destroying my home and my town. I took no other photos, although I was high above the valley floor. I didn't take photos of the scenes I saw because I didn't want to preserve that memory. I saw the destroyed lives of many people and the charred ruins of a previously scenic area. For those few moments, I saw hell.

I do not want to believe that climate change is real, but I have experienced it and I know the difference between one year and the next. Yes, the climate has changed before. It took 110,000 years for the last ice age to happen and return us to normal. My weather is changing drastically in four years.

We got sucker punched on the first two fires, but we came back - we are resilient and we are determined to make this place we call home safe. This time we were more than prepared. We have worked relentlessly for two years to be prepared. Our fire districts, county supervisors, our state government, and many experts in the field, all came together and developed a plan and that plan was executed to perfection and we were victorious! Our firefighters became heroes! We were saved, and maybe we can feel safe. There is no crystal ball, but I will bet on us, because we are not pushovers.

All Airlines offer a wide-range of connecting flights to destinations in the continental United States, Mexico, and beyond. For less stress, fly STS!

Jenny Chamberlain, District 4 Director, was a welcome guest. She told us that 39 counties were without power during the power outage from October 9-12. PG&E set up resource centers in 22 of those counties. She said that Supervisor Gore and others are pressuring PG&E to make changes for improvement.

#### SONOMA COUNTY AIRPORT OFFICIALS OPTIMISTIC ABOUT ADDING FLIGHTS NEXT SPRING

Riding strong commercial flight sales, Sonoma County airport expects to see expanded service to three international hubs starting next spring.

Alaska Airlines, which operates nine nonstop flights daily from Santa Rosa to five West Coast cities during summer peaks, will add a second daily trip to San Diego International Airport starting March 19. The year-round Southern California route is the airline's busiest from Charles M. Schulz-Sonoma County Airport, leading the Seattle airline to commit to its 10th flight next spring.

Not to be outdone, American Airlines, which began offering direct seasonal service to Dallas-Fort Worth International Airport in June, has signaled it will transition the route to a year-round service after the flight returns in the spring. That flight, which has logged average passenger capacities at better than 80% through September, is set to end Jan. 6 before returning on a more permanent basis on April 7. And there's a possible second daily flight from here to American's headquarters in the future.

United Airlines, which began nonstop service to Denver International Airport in March, also has indicated its 91% average passenger capacities through August aboard its 50-seat jet may lead the Chicago airline to shift to a 76-seat plane this spring. Alaska and American each already operate flights on the larger aircraft.

American and United's plans remain tentative, airport manager Jon Stout said. But local airport officials expect to firm up airlines' 2020 commitments around Thanksgiving.

Already this year, the regional airport saw more than 362,000 passengers through September — about an 8.5% increase from this time last year. Those numbers put Sonoma County on pace to surpass last year's record count of 440,000 passengers by another 40,000, Stout said.

#### CALIFORNIA BALLOT BID SEEKS TO REMOVE PROP. 13 COMMERCIAL PROPERTY TAX CAP TO FUND SCHOOLS, HOSPITALS, GOVERNMENT

California voters may soon get another chance to decide whether many commercial properties and operations should continue to be protected from the property-tax impacts of a hot real estate market.

Supporters of the measure say reform of 4-decade-old Proposition 13 allows for better funding of local schools, colleges, health care facilities and local government, and for converting long-held real estate into housing.

Opponents say the change will mean higher prices for consumers as owners pass tax increases on to tenants — a provision of many commercial property lease contracts — and in fewer hires as businesses compensate for those higher costs.

In mid-October, California Secretary of State Alex Padilla cleared the supporters of the initiative to start collecting the almost 1 million signatures needed by April 14 to qualify the measure for the November 2020 ballot.

"Our goal is 1.6 million signatures," said Alex Stack, communications director for Schools and Communities First, a Los Angeles-based organization that's the largest California campaign committee backers of the campaign. It had raised \$7.6 million in 2018 when it launched and through September of this year, the latest state data available. That was before a Nov. 2 launch of a statewide petition drive.

It's the latest attempt to change 41-year-old Proposition 13, which limits property-tax increases. Sixty-five percent of California voters approved Proposition 13 in 1978. It capped property taxes at 1% of assessed value as of the last change in ownership or new construction, and annual increases in the tax were limited to 2%.

# CALIFORNIA GOVERNOR SIGNS 18 BILLS EASING RESTRICTIONS ON HIGHER-DENSITY HOUSING, 'GRANNY UNITS'

Over the past four years, a suite of proposals has quietly chipped away at zoning only for single-family homes, attracting comparably little blowback.

Lawmakers have made it easier for homeowners to convert garages into residential space and build small freestanding homes, in their backyards. And on October 9, Gov. Gavin Newsom signed multiple bills into law that aim to spur construction, including legislation that will allow property owners to build a backyard home of at least 800-square-feet as well as convert a garage, office or spare room into a third living space.

# A WEEKEND OF TEAMWORK – AACTION RENTS AND THE LARKFIELD RESILIENCE FUND

On the morning of September 21, an unexpectedly sudden project got underway at Sutter Santa Rosa Regional Hospital, and it could make a world of difference to Larkfield families who are rebuilding. In under 24 hours, four local businesses came to an agreement to relocate trees from the grounds that will soon become the hospital's new expansion. The Larkfield Resilience Fund and Aaction Rents, represented at Sutter's groundbreaking ceremony by Brad Sherwood and Steve Plamann, respectively, along with help from Image Tree Service and approval from Sutter, combined their shared resources to get the job done.

The Larkfield Resilience Fund was established in October of 2018, on the one-year anniversary of the Tubbs Fire. The goal of the nonprofit is to provide the rebuilding communities of Larkfield with the resources they need to get back on their feet. While many homeowners had insurance that would cover portions of the rebuilding process, some needs were not met via insurance. Among the needs that arose was the fact that the many beautiful trees that lined the neighborhoods of Larkfield were burned down, and many new or rebuilding

homeowners do not have the means to personally re-green their neighborhood. To solve this issue, the Larkfield Resilience Fund began the Neighborhood Greening Project.

When Brad Sherwood, vice president of the Larkfield Resilience Fund, attended the groundbreaking ceremony for Sutter Santa Rosa Regional Hospital's new expansion, he realized that the Resilience Fund could use the trees and bushes that would need to be removed in order to provide Larkfield homeowners with the plants necessary to re-green. The challenge, of course, would be in removing the plants from the hospital grounds in a reasonable time frame. Fortunately for Brad, Steve Plamann of Aaction Rents was also present at the groundbreaking ceremony.

Steve, current president of the Mark West Area Chamber of Commerce, was thrilled with the idea of using the soon-to-be-removed trees and bushes to re-green the devastated neighborhoods of Larkfield. Because of this, he made Brad an offer: if Brad could provide the workers by the next day, Steve would provide two pieces of heavy equipment that Brad needed to complete the job. After gaining approval from Sutter, the agreement was made, and soon after Brad would obtain the services of Image Tree Service to provide the necessary operators for Aaction Rents machinery.

The next morning, on September 21, Brad oversaw the successful removal of four coast live oaks and six Japanese maples from the expansion grounds (as well as several bushes that were selected by Brad's children, June and Grant). With the workers from Image Tree Service and the machinery from Aaction Rents, the work was completed quickly, and now those plants will be given to homeowners in Larkfield to re-green their neighborhood.

Through Brad and Steve's efforts, Larkfield will be just a little bit greener in the not-too-distant future, and Brad is thankful for the support of the community for the Larkfield Resilience Fund. "The community support and collaboration has been tremendous," says Brad. "We had a great team that pulled together in a short time."

# NORTH BAY FINANCIAL INSTITUTIONS STEP UP TO HELP THOSE AFFECTED BY KINCADE FIRE, BLACKOUTS

Adapted from a story on the North Bay Business Journal website, November 27, 2019 Here is how some North Bay banks and financial institutions have stepped up to the plate.

#### **American AgCredit**

Mark West Area Chamber member American AgCredit has operations in Sonoma County and provides farmer and rancher financing. The financial service provider committed \$100,000 in total assistance. American AgCredit committed cash to the Sonoma County Farm Bureau. They also plan to give to the Sonoma County Grape Growers Foundation, Redwood Empire Food Bank and the American AgCredit Employee Relief Fund.

#### **Redwood Credit Union**

The Santa Rosa-based financial services nonprofit cooperative's support has focused on members, employees and the community at large. Redwood opened its main offices as evacuation centers for employees and their families. Financial assistance programs for impacted credit union members included 0% interest loans up to \$5,000 for urgent needs, discounted loans for autos, trailers and RVs, and automatic increases of credit and debit card limits.

#### **Exchange Bank**

Santa Rosa-based Exchange Bank is funding local nonprofits and charities that focus on food and housing to help with Kincade fire relief efforts. Exchange Bank has developed loan servicing and credit options to help customers and the broader community recover from the destruction wrought by the Kincade fire. This includes 90-day payment deferment and their Rebuild Loan Program that was started in 2017. Exchange Bank Larkfield Branch is a Chamber Corporate Sponsor.

#### **Wells Fargo**

Wells Fargo & Company previously announced a \$400,000 donation from the Wells Fargo Foundation to be divided between nonprofits supporting those affected by the Kincade fire and the Getty fire in Los Angeles.

#### **Bank of America**

Bank of America is offering assistance like fee refunds and loan repayment options as part of the bank's Client Assistance Program. Their Employee Relief Fund provides grants to help cover the costs of immediate needs and for support and resources ranging from counseling and back-up child or adult care to financial assistance.
