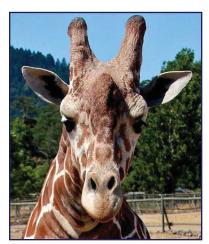

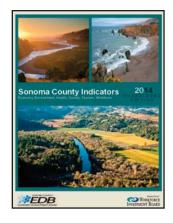

# NEW EDITION OF SONOMA COUNTY INDICATORS AVAILABLE

The Sonoma County Economic Development Board (EDB) has announced the 2014 Sonoma County Indicators Unabridged Edition. The report has been updated and expanded since the publication of an abridged edition in January 2014, in an effort to provide the most current and comprehensive annual data.

Some highlights and challenges in this report include:

- Sonoma County is a competitive place to do business both because of an attractive business climate and high quality of life shown thorough the high scores on the Innovative Environment Index and the Quality of Place Index, respectively.
- The seasonally unadjusted unemployment rate for Sonoma County was 5.3% in April 2014, a five-year low and below both the state wide and national averages. Job growth in Sonoma County was 4.3% from March 2013 to 2014, placing it 2nd among competing counties and 8th out of all counties in California.
- Sonoma County is leading the way in many environmental metrics, and providing other regions with examples of responsible environmental stewardship as we grow.
- Tourism indicators are overwhelmingly positive. Sonoma County's tourism industry added 790 jobs, or [an increase of] about 4% from 2011-12. Revenue from the transient occupancy tax (TOT) totaled \$27 million in 2013, an all-time high for Sonoma County. Together, state and local taxes generated by visitors totaled \$97.3 million in 2012.

#### **OVER 15,000 ATTEND AIR SHOW**

The Pacific Coast Air Museum held its annual Wings Over Wine Country Air Show on September 20 & 21, attracting a crowd of over 15,000 to the Charles M. Schulz-Sonoma County Airport.

Guests enjoyed thrilling aerial demonstrations and acts by the United States Marine Corps, Red Bull, and numerous veteran performers. Dozens of local vendors as well as non-profits supporting veterans and community services had booths, increasing their exposure and doing brisk business. Paying guests arrived from all over the greater Bay Area and Northern California, including thousands of kids and adults and many senior veterans. A posh fundraising gala was held on Friday September 19 in the Vine Jet hangar, which raised a sizeable amount of money to help the growing museum build a new and modern museum facility.

Next year's air show will be held September 26 & 27, 2015.

### SANTA ROSA AIRPORT GETS FINAL GRANT FOR EXPANSION: RUNWAY EXPANSION TO BE DONE MID-OCTOBER

SANTA ROSA — Charles M. Schulz–Sonoma County Airport received a \$932,714 grant from the U.S. Department of Transportation, the last of three grants the airport was seeking to complete the runway-expansion project, officials said Wednesday.

"That's great news, and we're right on schedule with the project," said Gina Stocker, marketing specialist for the airport.

The runway expansion should be done by mid-October. The most important is adding 885 feet of pavement to the main runway to make it 6,000 feet long, the length needed for regional jet

service. Once that is completed, the airport hopes to attract more airlines. Right now, Alaska Airlines is the sole commercial airline serving Sonoma County.

The entire airport project, which includes several other alterations, is scheduled to be completed in November. Total cost is \$53.8 million, 90 percent of which was federally funded.

Airport Manager Jon Stout is attending the World Routes conference in Chicago and meeting with industry representatives to discuss future airline service.

"The completion of this project will mean big things for Sonoma County and our region," said Rep. Mike Thompson, D-St. Helena, who was instrumental in securing government funding for the project. "Having an airport that's a short drive away, and that can accommodate travel to and from major inland airports, will attract more tourists and businesses to our area. That's an enormous economic win."

The project will help make Sonoma County more attractive to commerce because businesses will be able to more easily get back and forth from major inland cities, and fly customers or cargo in and out with greater ease.

Tourism could also see a boost as the project will make it easier for people around the country to get to Sonoma County.

The project will also improve safety by separating two runways that currently end at the same location. Creating two separate endpoints for the runways will help eliminate pilot confusion.

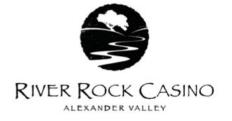

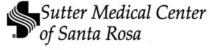
